NOTICE

Subject: Revision of Fine for Non-Vacation of Hostel Rooms / Occupation of Hostel Rooms by Luggage

All Undergraduate (U.G.) students are hereby informed that they were directed to vacate their respective hostel rooms within four (04) days after the completion of the End Term Examinations vide **Order No. Ch. C.O.W./2026/74 dated 29.04.2026**, issued to facilitate hostel maintenance and repair works.

Despite the above instructions and subsequent reminders issued from time to time, including the latest **Order No. Ch. C.O.W./2026/309 dated 04.07.2026**, it was observed that a number of students neither vacated their allotted hostel rooms nor handed over possession of the rooms to the respective Hostel Caretakers. In several cases, hostel rooms continued to remain occupied by students' luggage, thereby preventing the Institute from carrying out the scheduled maintenance and repair work.

Accordingly, a fine of **Rs. 100/- (Rupees One Hundred only) per day** was imposed for the period from **25.05.2026 to 30.06.2026**, amounting to **Rs. 3,500/- (Rupees Three Thousand Five Hundred only)** per defaulting student.

Subsequently, considering the representations received from the students, the matter has been reviewed by the Competent Authority. As a special one-time measure, it has been decided to revise the penalty. Accordingly, the fine has been reduced to **Rs. 50/- (Rupees Fifty only) per day** for the aforesaid period. Therefore, the revised amount payable by each defaulting student shall be **Rs. 1,750/- (Rupees One Thousand Seven Hundred Fifty only)**.

All concerned students are hereby directed to comply with the following instructions:

1. **Deposit the revised fine of Rs. 1,750/- (Rupees One Thousand Seven Hundred Fifty only)** in the respective Hostel Mess Account **on or before 12th July 2026 (up to 12:00 Noon)** without fail.
2. **This concession shall remain valid only up to the above-mentioned date and time.** Students who fail to deposit the revised fine within the stipulated deadline shall automatically forfeit the benefit of the revised penalty and shall be required to deposit the original fine of **Rs. 3,500/- (Rupees Three Thousand Five Hundred only)**, as notified vide **Order No. Ch. C.O.W./2026/309 dated 04.07.2026**.
3. Immediately after depositing the fine, students shall **vacate the previously allotted hostel room**, hand over vacant possession of the room along with the room key to the respective Hostel Caretaker, and complete all required hostel vacation formalities.
4. The proof of payment (receipt/transaction acknowledgement) shall be submitted to the respective Hostel Caretaker immediately after the payment for record and verification.

Students who fail to comply with the above directions within the stipulated time shall be liable for disciplinary action under the Hostel Rules. Such students shall also be ineligible for future hostel allotment until all outstanding dues are cleared. The Council of Wardens reserves the right to withhold hostel accommodation and initiate any other action as deemed appropriate under the Hostel Rules and Institute regulations.

This notice shall come into force with immediate effect.
