8.	Reporting Date & Time	02/09/2026 at 9.30 AM.
	Remuneration	Consolidated remuneration for the position of Internal Auditor will be ₹ 50,000/- to ₹ 80,000/- per month. Consolidated remuneration of the Internal Auditor shall not exceed the last pay minus pension as applicable in case of re-employment after retirement. No additional or other allowance will be payable.

Selection procedure: Selection of candidate will be based on his/her performance in the walk-in- interview. No TA/DA will be paid for appearing in the selection process. The candidates are required to come directly for the walk-in-interview without waiting for a call letter.
