NOTICE

Instructions for the candidates who have submitted their applications against Advertisement No. Estt/NFR/2024/1415 Dated: 21/10/2024

All candidates may go through the following instructions for compliance:

(1) Candidature of candidates shown Provisionally Eligible is purely provisional and is based on preliminary scrutiny of information provided by them. It creates no right in favour of any candidate and Institute reserves the right to debar a candidate for further stages of recruitment if information provided is found to be false/ incomplete. Merely appearing in list of Provisionally Eligible candidates does not guarantee that a candidate shall be called for Written test/Skill test (wherever applicable).

(2) Candidates who have been marked Not Eligible, if they like, may prefer a representation to the Institute, if they feel that reason mentioned for non-eligibility does not reflect the true position. Such representation, bearing title of the subject as **“Representation against Application No..... for the post of”**, citing cogent reasons along with supporting documents, may be submitted **09/03/2025** only through Email to recruitment@manit.ac.in **within 10 days of publication of these scrutiny results**, failing which their candidature shall be liable to be cancelled without any further notice. No vexatious representations shall be considered and no query on result of consideration of such representation shall be entertained.

(3) Candidates who have not submitted application earlier by Speed Post/Registered or whose application was received after the last date i.e. 04/12/2024 would not be considered for candidature now.

(4) Candidates who were found Provisionally Eligible due to deficiency in application/documentation (as mentioned in the remarks column of the list) have to submit (by email to recruitment@manit.ac.in) required documents/certificates bearing title of the subject as **“Representation against Application No..... for the post of”**, **within 10 days of publication of these scrutiny results**, failing which their candidature shall be liable to be cancelled without any further notice.

(5) E-mails received without prescribed subject and/or received after the prescribed date (i.e. **09/03/2025**) would not be considered under any circumstances. No individual communication is being sent to candidates, and Institute shall not be responsible to candidates who could not take appropriate action due to their failure to visit the website within stipulated time.

(6) The candidates who are serving in Government organization/Autonomous body/PSU etc. and have not submitted NoC or whose application has not been forwarded through proper channel shall have to submit NoC at least 7 days prior to the date of Written test.

(7) Candidates who have applied for the position of Superintendent under the OBC-NCL category but have not submitted a valid OBC-NCL certificate issued on or after April 1, 2024, must submit the valid latest OBC-NCL certificate at least 7 days prior to the written test. Failure to submit the required OBC-NCL certificate at least 7 days before of written test date will result in their candidature no longer being considered under the OBC-NCL category. Instead, their candidature will be considered under the UR category, provided they meet the essential eligibility criteria viz., educational qualification, age etc. outlined in the advertisement.

(8) Scheme, and date of Written test/Skill test (wherever applicable) etc. shall be notified separately for which candidates are advised to regularly visit the Institute website.
